The calculation of the final grade is based on the following formula:

$$W=x/2 + y/4 + z/4$$

where:

**x** – means the arithmetic mean of the credit marks and examination marks obtained by the student during the study, excluding the diploma examination,

**y** - means the mark or arithmetic mean of diploma examination/the mark or arithmetic mean calculated on the basis of the theoretical part of examination,

**z** - means the mark or arithmetic mean of the diploma thesis/the mark or arithmetic mean calculated on the basis of the practical part of examination.

The final study result is written down in the diploma according to the principle:

## **8. INFORMATION ON THE HIGHER EDUCATION SYSTEM IN POLAND**

### **8.1. Access to the higher education**

The total duration of education until completion of a school which offers the possibility of taking the secondary school leaving examination (*matura* examination) is 12-15 years. Having passed successfully the secondary school leaving examination (*matura* examination), graduates are awarded a secondary school leaving certificate which entitles them to apply for admission to a higher education institution.

### **8.2. Higher education system**

Higher education system in Poland and the basis for its operation are laid down in the Act of 20 July 2018 – The Law on Higher Education and Science (Journal of the Laws, item 1668, as amended).

Public higher education institutions are created by a state authority. Studies at higher education institutions are undertaken as first-cycle, second-cycle and uniform master's studies. Studies can be undertaken as full-time or part-time studies.

First-cycle full-time studies last at least 6 semesters, and if the study program includes learning outcomes which enable students to obtain engineering competences - at least 7 semesters. Second-cycle full-time studies last from 3 to 5 semesters. Full-time uniform master's degree studies last from 9 to 12 semesters.

Part-time studies may take longer than the corresponding full-time studies.

Qualifications obtained on graduation are assigned the level of the Polish Qualifications Framework set out in the Act of 22 December 2015 in the Integrated Qualifications System (Journal of Laws of 2018, item 2153, as amended).

The first-cycle diploma confirms the full qualification at level VI of the Polish Qualifications Framework. Second-cycle diploma and uniform master's degree diploma confirm the full qualification at level VII of the Polish Qualifications Framework has been awarded.

### **8.3. Titles awarded to graduates of higher education institutions:**

1) licencjat, inżynier and equivalent titles: inżynier architekt, inżynier pożarnictwa, licencjat pielęgniarstwa, licencjat położnictwa – awarded to graduates of the first-cycle programmes,

2) magister, magister inżynier and equivalent titles:

a) magister inżynier architekt, magister inżynier pożarnictwa, magister pielęgniarstwa, magister położnictwa – awarded to graduates of the second-cycle programmes,

b) lekarz, lekarz dentysta, lekarz weterynarii, magister farmacji, magister inżynier architekt – awarded to graduates of the long-cycle programmes.

### **8.4. ECTS credits**

In order to obtain a diploma of graduation of the first-cycle degree programme, the student is required to gain at least 180 ECTS credits, of the second-cycle degree programme – at least 90 ECTS credits, of long-cycle programmes – at least 300 ECTS credits if the studies last 9 or 10 semesters, or at least 360 ECTS credits if they last 11 or 12 semesters.
