y – means the mark of diploma examination/a mark from the theoretical part of examination,

z – means the mark of the bachelor's thesis/a mark from the theoretical part of examination.

#### 8. INFORMATION ON THE NATIONAL HIGHER EDUCATION SYSTEM

# 8.1. Access to the higher education

The total duration of education until completion of a school which offers the possibility of taking the secondary school leaving examination (maturity examination) is 12-15 years. Having passed successfully the secondary school leaving examination (maturity examination), graduates are awarded a secondary school leaving certificate which entitles them to apply for admission to a higher education institution.

# 8.2. Higher education system

Higher education system in Poland and the basis for its operation are laid down in the Act of 20 July 2018 – The Law on Higher Education and Science (Journal of the Laws, item 1668, as amended).

Public universities are created by a state authority. Studies at universities are conducted as first-cycle, second-cycle and uniform master's studies. Studies can be conducted as full-time or part-time studies. First cycle programme studies last at least 6 semesters, and if the study program includes learning outcomes enabling engineering competences, at least 7 semesters. Second-cycle programme studies last from 3 to 5 semesters. The stationary uniform master's studies last from 9 to 12 semesters.

Part-time studies may take longer than the corresponding full-time studies.

Qualifications obtained as a result of graduation as part of higher education are assigned the level of the Polish Qualifications Framework set out in the Act of 22 December 2015 on the Integrated Qualifications System (Journal of Laws of 2018, item 2153, as amended).

The first cycle diploma confirms the full qualification at level VI of the Polish Qualifications Framework. Second cycle programme diploma and uniform master's diploma confirm the full qualification at level VII of the Polish Qualifications Framework.

## 8.3. Degrees awarded to graduates of higher education institutions

- 1) licencjat, inżynier and equivalent degrees: inżynier architekt, inżynier pożarnictwa, licencjat pielęgniarstwa, licencjat położnictwa awarded to graduates of the first-cycle programmes,
- 2) magister, magister inżynier and equivalent degrees of magister:
- a) magister inżynier architekt, magister inżynier pożarnictwa, magister pielęgniarstwa, magister położnictwa awarded to graduates of the second-cycle programmes,
- b) lekarz, lekarz dentysta, lekarz weterynarii, magister farmacji, magister inżynier architekt awarded to graduates of the long-cycle programmes.

## 8.4. ECTS credits

To be awarded a diploma of graduation of the first cycle degree programme, the student is obliged to gain at least 180 ECTS credits, of the second cycle degree programme – at least 90 ECTS credits, of long-cycle programmes – at least 300 ECTS credits if the studies last 9 or 10 semesters or at least 360 ECTS credits if they last 11 or 12 semester.
